## Campsite Regulations for Motorhome/Tent Site

### Vilshofen on the Danube

Dear Guest,

You are at the designated motorhome parking and tent site for water and bike travelers set up by the city of Vilshofen an der Donau, located at Bootshafen 1.

We warmly welcome you and wish you a pleasant stay.

#### Registration and fees:

Fees Motorhome parking per night including electricity/disposal  
20.00 Euros

Tent site for one tent including max. 6 persons (electricity not available)  
6.00 Euros

Fees are to be paid in advance. The process is described under the "Registration" section.

Wifi: Bavaria WLAN is free of charge

#### Registration:

Motorhome:

- Retrieve your parking ticket and keep it for multiple entries and exits during your stay, as well as for departure on the day of leaving.
- Drive to an available parking space.
- Scan the QR code (next to the space number) with your phone at the parking space. If the space is available, you will be guided through the booking and payment process.
- If the space is not available, please choose another parking space. It is essential for a smooth process that you occupy only the space you have scanned/booked.
- The space must be vacated by 12:00 PM on the last day of booking; otherwise, fees for an additional night will apply.
- Within the booked period, the parking ticket allows for multiple exits and entries.

Tent site:

- Scan an available space with a QR code on the board at the terminal. You will then be guided through the booking and payment process. There are 20 spaces (codes) available.
- Choose an available space on the tent field (see site plan). Driving on the tent field with a car is not allowed.
- The space must be vacated by 12:00 PM on the last day of booking.

**Therefore, please observe the following campsite rules:**

In general, all guests are expected to show mutual consideration.

1. Parking on the motorhome site is only allowed for motorhomes with a valid parking permit. The maximum stay is limited to 14 days.
2. **Motorhomes and cars with roof tents are permitted** on the motorhome site. Caravans are not allowed. The vehicle length, including trailers or similar, is **limited to a maximum of 8m overall length**. Please adhere to the designated parking space markings and do not occupy any area outside the markings of the booked space.
3. The tent field may not be accessed by car, even for setup and dismantling. Cars must be parked in the designated parking spaces.
4. **Reserving pitches is not possible**. Please do not "block" other pitches with camping equipment.
5. Please be aware that spaces around trees carry certain risks due to falling leaves and branches; we do not assume liability for this.
6. The site is open from early April to late October.
7. Orderliness and cleanliness are the natural duties of all users of the site. All facilities and equipment must be treated with care.
8. Sanitary facilities must be kept clean and, if necessary, cleaned after use, with consideration for other guests.
9. The pitch must be left in proper condition before departure. All types of waste must be placed exclusively in the designated waste containers at the disposal station. Please observe waste separation.
10. Please leash your dog and promptly remove any waste.
11. It is not allowed to enclose pitches/vehicles with fences.
12. Ensure that no one is endangered or disturbed by users of the motorhome/tent site or their equipment. Any liability claims will be borne by the offenders.
13. Open fireplaces are not allowed on the motorhome site/tent site. The use of gas/charcoal grills is permitted, provided other guests are not bothered, and there is no general fire hazard.

**14.** We request considerate, quiet, and neighborly behavior. In the interest of all guests and neighbors, please avoid music and loud conversations during the **quiet hours from 22:00 to 07:00.**

As the operation of a single motorhome air conditioner at night would exceed the noise level in the neighborhood, visitors with motorhomes are prohibited from **using air conditioning units during the night from 22:00 to 6:00.**

15. Traffic rules (StVO) and walking speed apply on the site.

16. The operators or their authorized representatives are, in the exercise of house rules, entitled to refuse entry to individuals or to expel them from the premises if it appears necessary to maintain peace and order at the overnight accommodation site and in the interest of other users or neighbors.

17. Dirty water from mobile toilets and gray water must be disposed of exclusively at the designated disposal points (back of the terminal).

18. Any vehicle washing is prohibited throughout the entire facility.

19. Drinking water supply is provided through designated drinking water columns located at the disposal station, entrance barrier, and on the edge of the tent field. Power supply is provided through existing power columns.

20. In case of **emergencies**, please dial the corresponding emergency numbers:

Police	110
Fire department	112
Medical emergency service	116 117

For **malfunctions in the barrier system**, assistance can be obtained via telephone. The phone is located in a marked locker in the front area of the terminal.

21. Compliance with the instructions of the operator or staff, as well as the regulatory authority, must be adhered to, especially regarding the positioning of vehicles.

22. The site is unguarded. Use and access to the site are at your own risk.

23. Any claims for damages against the operators are excluded.

24. To maintain order and safety at the motorhome site/tent site, conducting business, selling goods, and exhibitions are prohibited.

25. By using the parking space, you accept our site regulations.
